### **About the Museum**

Court Barn Museum celebrates the talented designers and craftspeople who have worked in Chipping Campden and the north Cotswolds since the beginning of the twentieth century. This is a story of the Arts and Crafts movement and its legacy, a story of how a small town in a beautiful setting became a gathering place for designers and craftspeople of national and international reputation.

The permanent displays focus on nine individuals or workshops including C.R. Ashbee, Katharine Adams, F.L. Griggs, Gordon Russell, Hart Silversmiths and Robert Welch.

# Exhibitions, events and community engagement



The summer 2023 exhibition showcased the work of eight QEST (Queen Elizabeth Scholarship Trust) Scholars and promoted the important work that QEST undertakes in supporting craftsmanship in many disciplines. An excellent relationship with QEST has been established, promoting the museum as place of craft and design excellence.

Additionally, the Museum took part in ArtFund's The Wild Escape project, which asked children to explore the creatures in our collections and learn about the importance of biodiversity through a visit to the local orchard. Over 100 children took part from three local primary schools as well as the local scout group.

- Plan and chair the board meetings and the AGM, with others as appropriate.
- Act as a spokesperson and figurehead for Court Barn.

- A keen sense of strategic purpose to drive the Museum forward over the next 5 years through a period of uncertainty, taking confident decisions to act as a figurehead.
- An understanding of museums and their role and also of how small businesses operate.
- An inclusive leadership style: able to inspire and support everyone to participate on an equal footing to ensure effective management of employees, volunteers and trustees.
- Encourage trustee involvement/dialogue in relevant areas, lead on planning and ensure actions are followed up.
- The ability to listen and engage effectively and be comfortable with challenge and debate and are able to encourage that in others whilst fostering a collaborative board environment.
- Advocate be able and willing to champion Court Barn's work through personal networks, social media and other channels.
- A strong personal commitment to Equity, Diversity and Inclusion.
- Be responsive and able to support the management team on a regular basis, preferably in person.
- Share the same responsibilities and qualities of all trustees.
